Tournament Rules

All matches will be conducted using the current Contest Rules for Judo as stipulated by the International Judo Federation (IJF), with the following modifications:

1. Pre-2003 injury rules will be used, except Seinen Brown/Black divisions.
2. Pre 1994 contest rule will be used regarding Safety Zone and Out of Bounds Area.
3. Modified Double Elimination and Pool System will be used.

Yonen (Male and Female From 5 to 12 Years Old): Match Time: 2 ½ Minutes

1. No shime-waza (chokes)
2. No kansetsu-waza (arm locks)
3. Golden Score: 1:00 Minute

Shonen (Male and Female from 13-16 Years Old): Match Time: 3 Minutes

1. No kansetsu-waza (arm locks)
2. Golden Score: 2:00 Minutes

Seinen Novice Division (Male/Female 17 Years and Older): Match Time: 3 Minutes

1. Under the rank of brown belt
2. No kansetsuwaza (arm locks)
3. Golden Score: 2:00 Minutes

Masters (M/F) 35 years and older Brown/Black Belt Division: Match Time: 3 Minutes

1. No White Belts
2. IJF rules Regardless of Age
3. Golden Score: 2:00 Minutes

Seinen (Male/Female) Brown and Black Belt Division: Match Time: 4 Minutes

1. No White Belts
2. IJF rules Regardless of Rank or Age
3. Golden Score: 3:00 Minutes

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.

Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.

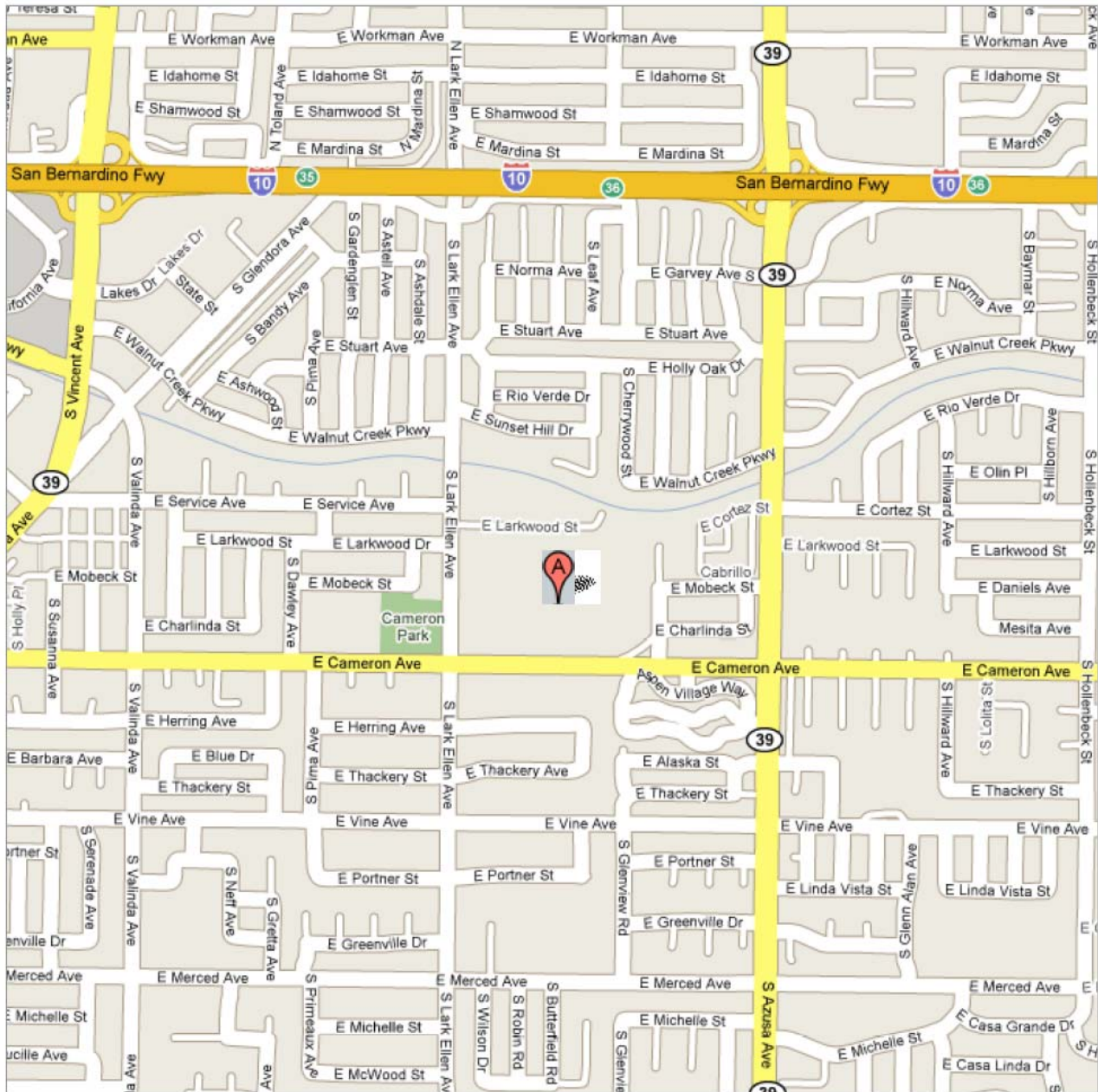

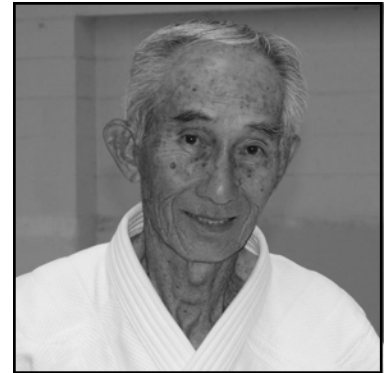
