All matches will be conducted using the current Contest Rules for Judo as stipulated by the International Judo Federation (IJF), with the following modifications:

1. Choking techniques will be allowed for ages **13 years and older** only.
2. Arm lock techniques will be allowed in the **Senior & Masters brown/black belt** divisions only.
3. Pre-1994 rules regarding Safety Zone and Out-of-Bounds area.
4. Pre-2003 rules regarding Medical Treatment-Modified Medical Treatment Rules.
5. All Non-Black Belts in a black belt division must sign a “Non-Black Belt Waiver”.
6. Full IJF competition rules in Sr. Brown & Black Belt Division regardless of Age or Rank.

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
